SUMMARY

[REDACTED] reports unwanted sexual contact to attorney [REDACTED] several weeks after incident. Federal law enforcement agencies refuse to investigate incident and refer [REDACTED] to Portland Police Bureau.

After [REDACTED] cancels three appointments for interview of [REDACTED] declines police assistance in investigation and states the case is going to be pursued in Civil Court.

NARRATIVE

On December 19, 2006, I was assigned a confidential internal investigation involving [REDACTED] and AL GORE.

Sergeant Rich Austria told me he had spoke briefly with [REDACTED] regarding the case. [REDACTED] had contacted the US Secret Service, The Federal Bureau of Investigation and Oregon State Police in an attempt to have a larger law enforcement agency investigate this case. All above agencies declined and referred him to the agency of jurisdiction where the alleged crime occurred.

I spoke briefly by telephone with [REDACTED]'s attorney [REDACTED] told me, [REDACTED] reports unwanted sexual contact by AL GORE during a [REDACTED] appointment at a local upscale hotel on October 24, 2006. He did not want to discuss the details of the case rather made an appointment for Detective Sergeant Austria, Detective Daul and myself to interview [REDACTED] at 0900 hours on December 21, 2006 at his office.

On December 21, 2006, at 0700 hours, I received a message on my desk phone that [REDACTED] was unable to make the appoint due to personal reasons and we rescheduled for December 26, 2006 at 1500 hours again at his office.

I contacted Sergeant Austria and informed him of the status of this case.

This case is exceptionally cleared as [REDACTED] refuses to cooperate with the investigation or even report a crime.
